He was a graduate of pacational school of Samoana High School and was active in village affairs on Aunu'u.

His body arrived by air Saturday night, escorted by Marine Staff Sergeant Fred Daumalder. It was taken to Aunu'u on the Manusina yesterday morning.

## Legislature Continues Session

The Legislature continued its special session today with consideration of a request for an appropriation for the Samoan pay maise.

The session began Wednesday with members of the House and Senate sitting as a com-

mittee-of-the whole.

Friday the committee approved the appropriation of \$25,000 for a study of medical care in the territory. The measure still must be debated and acted upon in each house before it is finally approved.

The lawmakers met Saturday morning with a delegation of West Coast educators which is

making a survey of the American Samoa school system.

## APOLLO ASTRONAUTS TAKE FINAL PHYSICAL EXAMS

CAPE KENNEDY (UPI) - The three men who are slated to fly to the moon were undergoing physical examinations today. Astronauts Frank Borman, James Lovell and William Anders were getting their final medical checkouts before boarding Apollo 8 Saturday for a 280,000 mile Christmas time voyage.

All three crewmen were said to be in perfect physical condition. They've been immunized against Hong Kong flu. But they were staying close to their moonport quarters anyway to minimize the chance of catching cold. An infection would scrub the mission.

The final countdown for the lunar orbital flight began last night.

KENNEDY PRAISES NATION'S YOUTH

SANTA CLARA, California (UPI) - Massachusetts Senator Edward Kennedy says the efforts of American youth brought about a bombing halt in Viet Nam and other major peace moves.

Receiving an honorary degree at the University of Santa Clara in California, last night, Kennedy told his audience that the lessons of Viet Nam are, "helping to ease racial tensions in this country." Kennedy said, "Last summer was the coolest summer in years. And if Martin Luther King had not been killed, it would have been even cooler."

CRIME SHOWS MAJOR INCREASE WASHINGTON (UPI) - The nation's crime rate is sharply up again. The FBI today released its latest statistics. They said crime in the cities is up from last year by 21 percent, and in the suburbs has risen by 19 percent.

The violent crime category is even higher than the general figures, with a 22 percent rise. FBI Director J. Edgar Hoover said the gun is getting more popular than ever. Its use in the commission of crimes has increased by about 25 percent over 1967.

But many authorities say the picture isn't as bad as it looks. Part of the rising crime figures are explained by much better reporting of statistics in recent years by local police agencies on whose figures the FBI totals are based.

## HOOVER WILL REMAIN IN TOP FBI POST

WASHINGTON (UFI) - FBI Director J. Edgar Hoover, who will be 74 years old on January 1, will be at his desk on inauguration day.

A spokesman for President-Elect Nixon said Hoover has agreed to stay on for another

tour of duty.

Like President Johnson four years ago, Mr. Nixon must sign a waiver of the compulsory retirement age of 65 to allow Hoover to continue on the job.

COURT PRESIDENT NO RULE ON RESERVE CALL-UP

WASHINGTON (UPI) - The Supreme Court today refused to step into the case of Army reservists fighting against duty in the Viet Nam war. The court refused to look into the government's right to call up reservists in such "underlared wars." The government says the law allows the President to call up any reserve unit for a period up to 24 months of duty.

In other actions:

The court upheld a 1968 amendment to the Selective Service law. The provision requires that a man whishing to challenge his classification either submit to induction before filing suit or refuse induction and use his claims as a defense when prosecuted. The high court's ruling reversed a San Francisco court which had ruled the amendment unconstitutional.

The court ordered a stay in the merger of five railroads which want to join to create the nation's longest rail system, running from Chicago to Seattle and from Canada to the Gulf of Mexico. The court halted the merger until it decides whether or not to hear the Justice Department's case against the consolidation.

The justices refused to hear arguments on a Los Angeles court order which clamps a public muzzle on persons connected with the Robert Kennedy assassination case. Prosecuting Attorney Evelle Younger claimed the court-ordered gag would muffle free speech and give rise to irresponsible speculation about the assassination. Arab Immigrant Sirhan Sirhan stands trial for the murder in superior court January 6.

CAIRO (UPI) - Jordan reported an Israeli attack today on a settlement south of the Dead Sea. A Jordanian woman reportedly was killed during the shelling and five other persons were injured. Israeli spokesmen admit the attack, but say no casualties resulted.

In Cairo, the semi-official newspaper Al Ahram accused Israel's defense minister of "Blackmailing" the U. S. Today's report said Moshe Dayan is in the U. S. to pressure President-Elect Nixon into unlimited support of his country.
